### Our department

**Clinical-Pharmacology Unit (CPU)** is one of new departments of the Thomayer Hospital specializing in providing studies in early phases of clinical drug and device development. The Unit has a capacity of 24 (28) beds with standard equipment to provide pharmacokinetic & bioequivalence studies as well as phase I, I/II studies. Within the Unit we are providing also later stages (phase II/III) in cooperation with other departments of the Thomayer Hospital.

Other cooperating departments are: Internal Department I. and II., Diabetology and other specific outpatient clinics, Oncology, Rheumatology, Pneumology, Geriatry, Infections diseases department, Emergency Department-ICU, Pediatric Department, extensive Hospital Labs etc.

Within the **Thomayer Hospital**, the Clinical studies are being performed for many years. In the mentioned Clinical departments studies are provided to assess effectivity (& safety) before registration of drugs (phase III.studies). Every year, Multicentric Ethics Committee of this hospital approves around-40-50 clinical studies and projects. Big pharmaceutical companies and CROs are regularly bringing their studies in clinical departments and quite often they go through our department, CPU that plays sometimes the coordinating role, other time CPU offers the clinical service and in cooperation with specialist (Investigator) from different department it is also a place to provide the study visits.

CPU has been inspected by the state Regulatory Authority (State Institute for Drugs Control) in 2009 and found to be compliant with GCP standards. The CPU is certified to provide clinical drug and device - studies phase I-IV under ISO 9001/2008 (2010, followed by ISO audits provided annually)
